Fund description and summary of investment policy

The Fund invests in a focused portfolio of African securities that are selected for their expected risk and return profile. The Fund may invest a substantial portion of the assets in a single country or region rather than a diversified portfolio of assets.

Classification: Africa - Interest Bearing

Fund objective and benchmark

The Fund seeks to achieve the maximum US dollar total return while minimising the risk of loss within the context of an African bond fund. The benchmark is the FTSE 3 Month US T Bill + 4% Index.

African security markets

There are numerous risks involved in investing in African security markets. These risks may be significantly higher than in more developed markets and may include (but are not limited to) the following:

- Individual countries may impose capital controls preventing the repatriation of foreign currency
- Returns are expected to be more volatile, and the average drawdown may be higher, than in more developed markets
- Low liquidity whereby subscriptions into the Fund may have to be phased in, and redemptions from the Fund may be limited per dealing day
- Market prices may not accurately reflect the fair value of a Fund asset and fair value pricing may be used

How we aim to achieve the Fund's objective

We assess an asset's intrinsic value based on long-term fundamentals and invest where our assessment of intrinsic value exceeds the price by a margin of safety. This approach allows us to identify assets that may be out of favour with the market because of poor near-term prospects, but offer good value over the long term.



Meeting the Fund objective

The Fund seeks to achieve the maximum US dollar return while minimising the risk of loss within the context of an African bond fund. The Fund experiences periods of underperformance in pursuit of this objective. Since inception, the Fund has outperformed its benchmark and delivered positive absolute returns in US dollars.

Subscription and redemption charge

Investors will be charged 0.5% when subscribing for Fund shares and 0.5% when redeeming Fund shares. These charges are paid into the Fund to offset the costs associated with the transactions that are borne by the Fund. Allan Gray Bermuda Limited (the "Investment Manager") may waive these charges at its discretion, for example in the case of significant offsetting between subscriptions and redemptions.

Annual management fee

The management fee consists of a fixed fee of 0.70% p.a.

Total expense ratio (TER) and transaction costs7

The annual management fee charged is included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one- and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately.

The Africa Bond Fund has seen strong US dollar returns of 26.9% over the course of the last year. Such returns have been surprising to some investors, when one considers the rough few years that the African sovereign universe has faced. The combination of a global pandemic, supply chain disruption, terrorism, military coups, drought, the strong US dollar index, high oil prices, excessive inflation and foreign exchange shortages has led to the breaking of pegs, widening deficits, limited access to borrowing, rising interest costs and a slew of government debt defaults. Within such an environment, however, there have been many good opportunities to pick up undervalued and distressed paper. Looking ahead, many countries remain in a more vulnerable position than they were pre-COVID-19, with significant imbalances and reduced market access to financing. This could present additional opportunities to find inefficiently priced securities to invest in.

One of the major events in the last quarter was Ghana's finalisation of the terms of its offshore debt restructure. Ghana announced a debt moratorium on its Eurobonds in December 2022 and has spent 18 months in default. While this may sound like a long time, Zambia spent four years in default on its Eurobonds while it worked to finalise an agreement with its many international creditors. The terms of Ghana's restructure broadly mean that Eurobond holders will trade in their bond holdings in exchange for new bonds that have a lower coupon rate and longer period to maturity. While Ghana's debt burden (as a percentage of GDP) will still be elevated at 78% post the restructure, the longer-dated debt allows Ghana more time to pay off its bonds and, hopefully, grow its economy and government revenues in the meantime.

The terms attached to the debt resolution also require Ghana to enforce greater fiscal austerity by reducing government grants and subsidies and restricting the size of the public sector wage bill so that the economy does not descend into distress once again. We remain sceptical of Ghana's ability to achieve

these reforms, especially given the ongoing drought and agriculture's outsized contribution to GDP via cocoa, palm oil and coffee production, as well as the sector's importance to domestic consumption, exports and labour force employment. We also note with concern that local currency borrowing yields have risen to as high as 27% of late, which will ultimately raise Ghana's debt costs beyond the threshold that was targeted under the debt restructure. That said, the investment case for our current positioning rests on the material pricing upside we expect from the Eurobonds that are punitively priced relative to the present value haircut implied under the new debt terms.

The Fund's biggest underweights – namely Nigerian and Kenyan government bonds, which we do not own – have served us well this year. The naira has lost 54% of its value in the last 12 months while Kenyan and Nigerian Eurobonds have been some of the poorest performers in the African dollar bond space. Local Kenyan citizens rioted earlier in the year in protest of the government's proposal for new taxes to improve state finances and allow access to more International Monetary Fund financing. The subsequent scrapping of these tax proposals has left a hole in Kenya's budget, which now suggests that large debt arrears will be accumulated.

In the last quarter, the Fund switched some of its Senegalese six-year Eurobonds into longer-dated and higher-yielding Senegalese paper in order to take advantage of market weakness. Despite the political upheaval caused by the upcoming November snap elections as well as the missed current-year government revenue targets, we base our investment case in large part on the revenue from oil and gas projects, which should ramp up over the next two years.

Share price

Share prices are calculated on a net asset value basis, which is the total market value of all assets in the Fund, including any income accruals, less any permissible deductions from the Fund, divided by the number of shares in issue. Forward pricing is used. The weekly price of the Fund is normally calculated each Friday. Purchase requests must be received by the Registrar of the Fund by 17:00 South African time on that dealing day to receive that week's price. Redemption requests must be received by the Registrar by 17:00 South African time on the dealing day on which shares are to be redeemed to receive that week's price. Share prices are available on www.allangray.co.za.

Fees and charges

Permissible deductions from the Fund may include management fees, brokerage, securities transfer tax, auditor's fees, bank charges and custody fees. A schedule of fees, charges and maximum commissions is available on request from the Representative.

Total expense ratio (TER) and transaction costs

The TER is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one- and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance the animal management less that have been charged (both the less at benchmark and any performance component charged) and other expenses like audit fees. Transaction costs (including brokerage, securities transfer tax and investor protection levies where applicable) are shown separately. There are no explicit brokerage charges in global bond markets. The broker rather takes an undisclosed spread between the purchase and sale price. The spread (charge) can vary from negligible to substantial depending on the asset and market circumstances. The disclosed transaction charge is therefore zero but in reality, there are transaction costs which reflect in the Fund's returns. We aim to minimise costs by keeping our trading activity to a minimum and always seeking out the most favourable price when buying and selling assets. Transaction costs are necessary costs in administering the Fund and impact Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time, including market returns, the type of fund, the investment decisions of the investment Manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and transaction costs should not be deducted from published returns. As collective investment scheme expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. The TER and other funds' TERs should then be used to evaluate whether the Fund performance offers value for money. The sum of the TER and transaction costs is shown as the total investment charge (TIC).

African markets

Capacity

The Fund currently has limited capacity. The Investment Manager may, at its discretion, refuse a subscription or phase a subscription into the Fund over a number of dealing days. Total investor redemptions may be limited to US\$5m or 2.5% of the Fund (whichever is less) per dealing day. The Investment Manager retains the right to distribute all or part of any redemption proceeds in specie (in kind).

Fair value pricing

The board of directors of the Fund (the "Board") may fair value the Fund's assets in accordance with the Board's fair value pricing policies if: 1) the closing market quotations or official closing prices are not readily available or do not accurately reflect the fair value of a Fund asset; or 2) the value of a Fund asset has been materially affected by events occurring before the Fund's pricing time but after the close of the exchange or market on which the asset is principally traded. The Board delegates the responsibility for fair value pricing decisions to a valuation committee of the Investment Manager.

Contractual risk

The Fund can use derivatives to manage its exposure to currencies and/or interest rates and this exposes the Fund to contractual risk. Contractual risk includes the risk that a counterparty will not settle a transaction according to its terms and conditions because of a dispute over the terms of the contract (whether or not bona fide) or because of a credit or liquidity problem, causing the Fund to suffer a loss. Such contract counterparty risk is accentuated for contracts with longer maturities where events may intervene to prevent settlement, or where the Fund has concentrated its transactions with a single or small group of counterparties.

Derivatives

Borrowing, leveraging and trading securities on margin will result in interest charges and, depending on the amount of trading activity, such charges could be substantial. The low margin deposits normally required in futures and forward trading, which the Fund may utilise, permit a high degree of leverage. As a result, a relatively small price movement in a futures or forward contract may result in immediate and substantial losses to the investor. Price movements of forward contracts and other derivative contracts in which the assets of the Fund may be invested are highly volatile and are influenced by, among other things, interest rates, changing supply and demand relationships, trade, fiscal, monetary and exchange control programmes and policies of governments, and national and international political and economic events and policies. Forward contracts are not traded on exchanges and are not standardised; rather, banks and dealers act as principals in these markets, negotiating each transaction on an individual basis.
